#### CONDITIONS

All stallholders must ensure that stalls are of show standard with suitable stands and backing. This MUST be adhered to in the interests of all stallholders and exhibitors. Stallholders shall not assign or sublet any part of allocated space without the consent in writing of the Chief Space Steward. The site allocated MUST NOT be changed without the approval of the Chief Space Steward.

The Society reserves the right in unforeseen circumstances to amend or alter the exact site of the location of the stand, and the Exhibitor undertakes to agree to the alteration to the site or the space re-allocated by the Society.

**N.B.** Care should be taken in selecting suitable lines. The Secretary or Chief Space Steward shall be given power to enter the area prescribed and remove any article, sign, picture or printed matter, as per the Federal Council of Agricultural Society's list of "Banned Items".

Stall holders are advised that their stalls must be set up and ready for operation by 9.00am Friday, 2 February & Saturday, 3 February 2024. The Trade Pavilion doors are opened to the public at 9.00am and it is the responsibility of Traders to be there to man their stands by that time. The Showgrounds (including the Pavilion) will be open for setting-up purposes from 9.00am until 7.00pm on Thursday, 1 February 2024 and from 7.00am on Friday, 2 February 2024. <u>Closing times</u>: All stall holders must trade from 9.00am to 8.00pm Friday and from 9.00am to 4.00pm Saturday (VEHICLES MUST NOT ENTER THE TRADE PAVILION TILL AFTER 5.00PM ON SATURDAY). OUTDOOR STALLHOLDERS must NOT have any

MUST NOT ENTER THE TRADE PAVILION TILL <u>AFTER 5.00PM</u> ON SATURDAY). OUTDOOR STALLHOLDERS must NOT have any vehicles in their area until all entertainment is finished on Saturday night, 3 February 2024. ONLY ONE VEHICLE AND TWO ATTENDANTS FOR THE TWO DAYS ARE ALLOCATED TO EACH SITE!

#### **IMPORTANT NOTICE TO ALL EXHIBITORS**

Any exhibitors intending to bring electrical equipment to the Showgrounds will be required to ensure that such equipment is fitted with **earth leakage circuit breakers** and that all electrical leads, tools and appliances have been inspected and tagged by a licensed electrical contractor. This is essential for the safety of yourself, your fellow exhibitors and the general public and is a requirement of **Workplace Health and Safety Act of 1989**. The Act imposes very severe penalties in the event of non-compliance with its provisions. Any exhibitors who do not comply will not be allowed to exhibit at the Stanthorpe Showgrounds. Please check all your electrical equipment and leads before you come, to avoid any difficulties.
